Projects Addressed

The Talis Park CDD board concluded a very active and successful season by addressing many projects that dealt with system and community wide upgrades, repairs, replacements, and improved efficiencies. These projects included:

- South Side Berm Project - Irrigation and Plant Replacement
- North Side Berm Project - Irrigation and Plant Replacement
- Corsica Lake Aerator Upgrades & Vegetation Removal
- Aerator Solar Panel Repairs
- Veterans Memorial Blvd Sidewalk Trip Hazard Shaving
- Lake Tadpole Removals - In Coordination with Land Based Removals
- Veterans Memorial Blvd Landscape Vendor Change & Price Negotiation
- Veterans Memorial Blvd Streetlight Repairs and Upgrades
- I-75 Talis Park Monument Sign Light Upgrades

South Side Berm Project

- Blue Landscaping completed the South Berm project in late 2024
- Project included irrigation installation, native Florida plant installations, filtration installation, tree trimming/reducing, and Clusia hedge and Oak Tree install to block I-75 view.
- Berm Tree work included flush cutting and thinning/reducing



North Side Berm Project

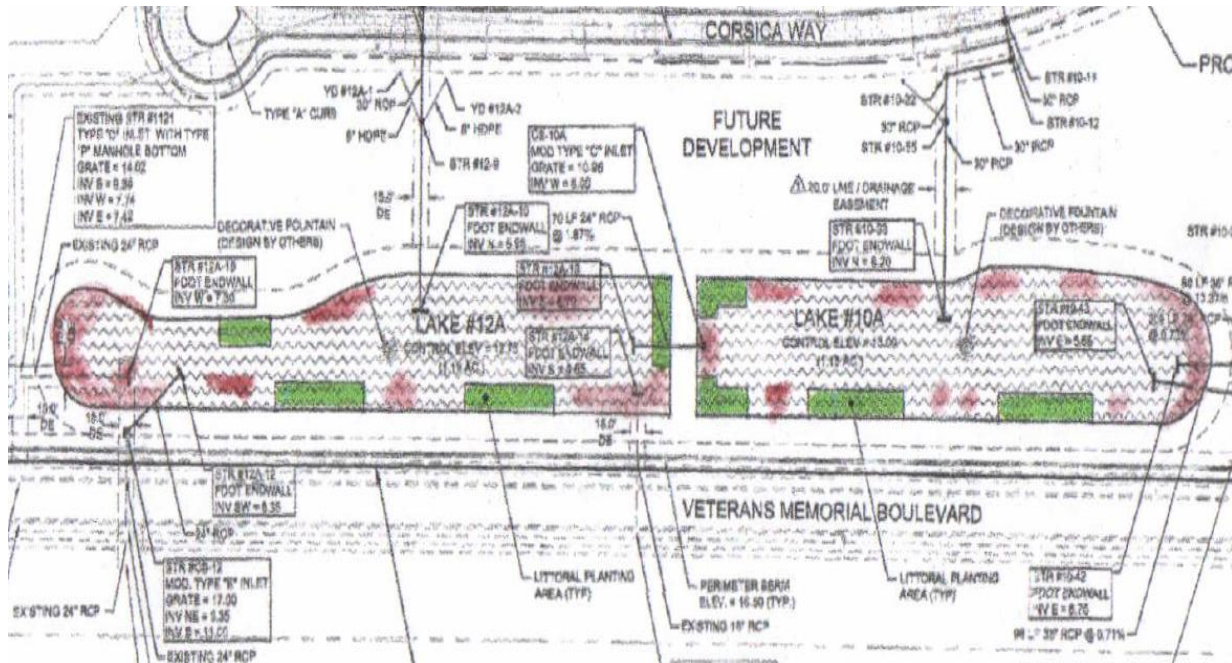
- Blue Landscaping completed the North Berm project in Jan 2025
- Project included irrigation installation, native Florida plant installations, filtration installation, tree trimming/reducing, and Clusia hedge and Oak Tree install to block I-75 view.



Corsica Lake Aerator Upgrades & Vegetation Removal

- Crosscreek Environmental completed vegetation removal and aerator upgrades in Nov 2024
- Various locations of Bullrush removed from lake
- Project included removal of solar panels, hard wiring the power, relocating the aerator cabinets above the high-water line, and installing 2 additional aerator lines.

Golf Course Lake Solar Panel Repairs

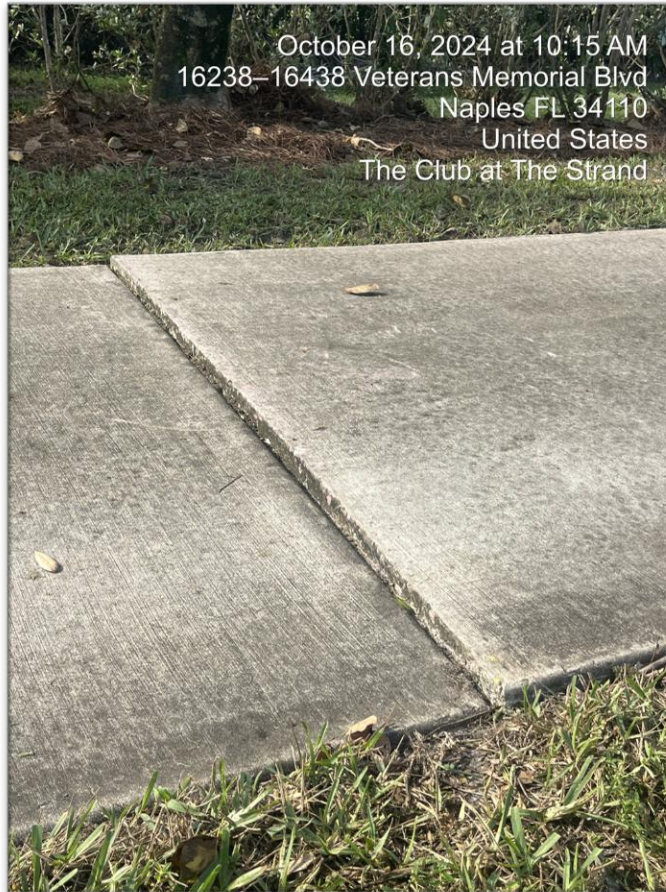
- Crosscreek Environmental completed necessary repairs to multiple damaged golf course lake solar panels in 2025



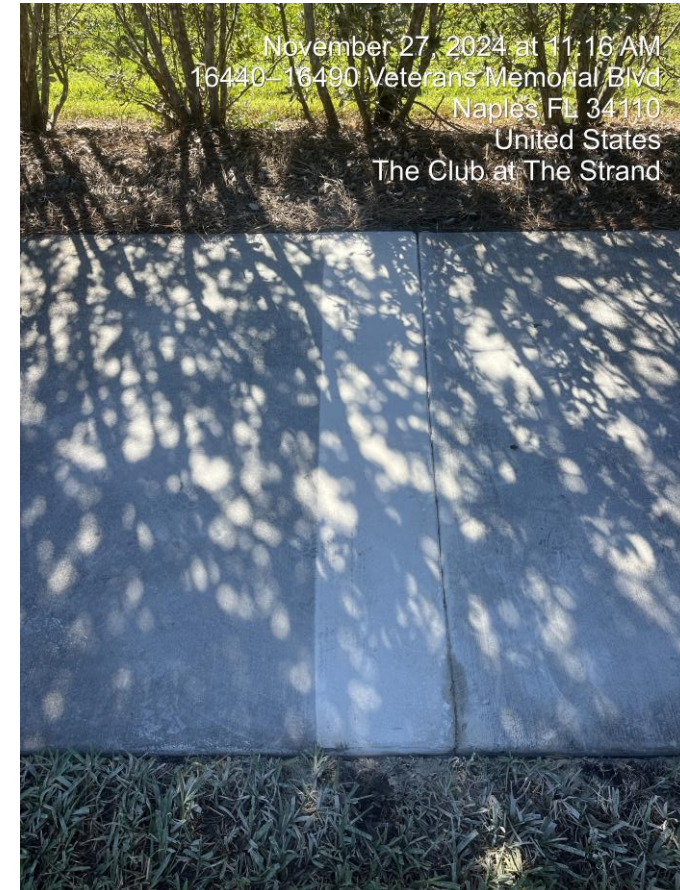
Veterans Memorial Blvd Sidewalk Trip Hazard Shaving

- Florida Sidewalk Solutions removed trip hazards along Veterans Memorial Blvd sidewalk in November
- These repairs shave the trip hazard down to proper accessibility standards

Corsica Lake Tadpole Removals

- Pesky Varmints completed routine tadpole removal and additional removals services in the first half of 2025
- Pesky Varmints is scheduled for 2 annual visits and additional visits can be completed as requested

- Picture shows active tadpoles outside of annually scheduled visits
- Pesky Varmints scope of work is to remove tadpoles before they grow into toads

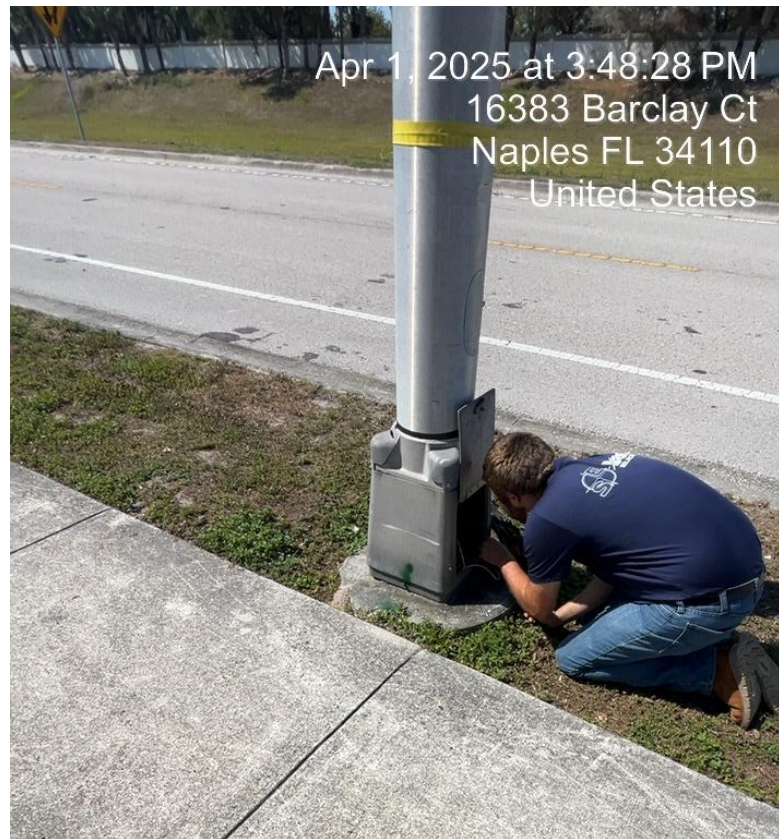


Veterans Memorial Blvd – Landscape Vendor Change & Price Reduction

- The Board of Supervisors provided direction to staff to bid out Veterans Memorial Blvd Landscaping Pricing
- Vision Landscaping was approved to begin landscape maintenance services in early 2025
- Vendor change will result in approximately \$60K savings to the District

Veterans Memorial Blvd – Streetlight Repairs & Upgrades

- Bates Electric identified burnt/damaged wire and replaced approximately 600 ft with new wire
- The Board of Supervisors approved lighting upgrades to LED bulbs to enhance lighting coverage and reduce annual operating cost



I-75 'Talis Park' Monument Sign Light Upgrades

- Lykins Signtek completed backlit letter upgrades in April 2025
- This provides better visibility and upgraded appearance for the Talis Park name and logo
